Dealer Temporary Tag Rules & Reminders

Per 20 V.I.C. § 336

- Only licensed dealers can apply for temporary plates.
- Plates are valid for **30 working days** (excluding weekends and legal holidays).
- Only one temporary plate is required and must be attached to the rear of the vehicle.
- Temporary tags must be returned to the Bureau of Motor Vehicles (BMV) when regular license plates are issued.
- Once a temporary tag is issued to a vehicle, the tag issuance information **must be submitted to the BMV** within 24 hours using the official Tag Issuance Form.
- The completed Tag Issuance Form must also be sent to the **BMV Director** and the **Police Commissioner**.
- Misuse of temporary tags may result in the **immediate surrender of all unused temporary plates** and **loss** of plate privileges for one year.
