**All documents must be original**

**The REAL ID Act of 2005 requires the following documents:**

**Important Notes for Real ID and Appointment Scheduling:**

- **Real ID Processing Time:** When applying for a Real ID, please be aware that there is a 1-month processing time. You will receive a temporary license until your Real ID is approved.
- **Online Appointments:** You can now schedule your appointment online or by phone.
- **Appointment Cancellations:** To cancel an appointment, you must do so at least 48 hours in advance. Cancellations can be made by calling or visiting your nearest BMV office.
- **Fees.** To apply for your driver's license, the following fees are assessed (note: fees may change):
  - Driver Manual - \$20.00 (for preparation of the Knowledge Skills Exam/Written Test)
  - Knowledge Skills Exam - \$20.00 (a passing grade of 75% or higher is required)
  - Learner's Permit - \$20.00 (issued after passing the Knowledge Skills Exam, valid for 6 months)
  - Road Skills Exam - \$20.00 (to be scheduled after meeting the above requirements)
  - Driver's License - \$55.00 (issued after passing the Road Skills Exam, with 5-year validity)
