Important Notes for Real ID and Appointment Scheduling:

- **Real ID Processing Time:** When applying for a Real ID, please be aware that there is a 1-month processing time. You will **receive a temporary license** until your Real ID is approved.
- **Online Renewal Portal:** Visit <https://mybmv.bmv.vi.gov/> to submit eligible renewals, upload documents, and pay fees. Monitor the portal. You will be contacted regarding status updates or requests for additional documentation. REAL ID renewals require an updated photograph.
- **Fees:** The following fees apply when obtaining a driver's license (*fees are subject to change*):
 - Driver Manual - \$20.00 (for preparation of the Knowledge Skills Exam/Written Test)
 - Knowledge Skills Exam - \$20.00 (a passing grade of 75% or higher is required)
 - Learner's Permit - \$20.00 (issued after passing the Knowledge Skills Exam, valid for 6 months)
 - Road Skills Exam - \$20.00 (to be scheduled after meeting the above requirements)
 - Driver's License - \$55.00 (issued after passing the Road Skills Exam, with 5-year validity)
- **Appointment Cancellations:** Reply C to cancel by text, or contact your nearest BMV office (48-hour notice required).
